JASPER MINING CORP. COMPLETES \$21,000 NON-BROKERED FINANCING

Jasper Mining Corporation (the "Company") has completed the non-brokered private placement financing announced on April 2, 2008. This private placement was originally announced as a brokered private placement which was in error. The Company raised \$21,000 through the sale of 60,000 units, each unit consisting of a common share and a one-half share purchase warrant. The financing was placed with an accredited investor. The 60,000 common shares and any shares acquired on exercise of the warrants are subject to a four month hold period. The share purchase warrants permit the purchase of 30,000 shares at an exercise price of \$0.50 per share until October 7, 2009.

In addition to a cash fee of \$1,050.00 the Company has also issued finder's share purchase warrants to purchase 6,000 shares at an exercise price of \$0.35 per share until October 7, 2009.

The TSX Venture Exchange's final acceptance bulletin is expected in the ordinary course.
